Mono County Issues Indoor Mask Order Following Increase in Local COVID-19 Cases

Effective **Friday, August 6,** Dr. Richard O. Johnson, Acting Public Health Officer for Mono County, issued a Local Health Order requiring the use of face coverings for both vaccinated and unvaccinated residents and visitors within indoor public spaces.

This Order will remain in effect until rescinded, in writing, by the Mono County Health Officer based on three consecutive weeks of adjusted case of below 6.9 per 100,000. As of July 24, the county's case rate per 100,000 was 15.3.

"During the last six weeks, increased interactions among members of the public have resulted in an increased number of daily new COVID-19 cases in Mono County, with case rates more than quadrupling since reopening on June 15," said Bryan Wheeler, Mono County Director of Public Health. "Community transmission of COVID-19 within Mono County is now considered Substantial by the Centers for Disease Control and Prevention (CDC) indicators, and we anticipate the rate to continue to increase over the coming days and weeks."

The Order includes the following:

- All persons within Mono County and the Town of Mammoth Lakes, regardless of vaccination status, shall wear face coverings while in indoor public settings, venues, gatherings, and businesses (examples include offices, retail, restaurants, theaters, family entertainment centers and meetings, among others).
- Individuals, businesses, venue operators, or hosts of public indoor settings must require all patrons to wear masks, for all indoor settings, regardless of their vaccination status, and post clearly visible and easy to read signage at all entry points to communicate the masking requirements for patrons.
- Recommendation: <u>It is recommended that all persons wear face coverings while</u> attending large outdoor public events.

The following individuals are exempt from wearing masks:

- Persons younger than two years old. Very young children must not wear a mask because of the risk of suffocation.
- Persons with a medical condition, mental health condition, or disability that prevents wearing a mask. This includes persons with a medical condition for whom wearing a mask could obstruct breathing or who are unconscious, incapacitated, or otherwise unable to remove a mask without assistance.
- Persons who are hearing impaired, or communicating with a person who is hearing impaired, where the ability to see the mouth is essential for communication.
- Persons for whom wearing a mask would create a risk to the person related to their work, as determined by local, state, or federal regulators or workplace safety guidelines.

A number of counties have issued similar Orders in the past few weeks, including many of Mono County's drive market counties such as Los Angeles County. In addition, both the CDC and the California Department of Public Health (CDPH) recently recommended that unvaccinated and fully vaccinated individuals wear a mask in public indoor settings in areas of Substantial or High transmission.

Mammoth Lakes' Town Council Allocates \$1.5 million to Access Apartments

Mammoth Lakes Housing, Inc. (MLH) is excited to announce that it is \$1.2 million closer to starting construction on eleven one-bedroom apartments. The Mammoth Lakes' Town Council approved an increased funding commitment to the Access Apartments project at their July 21st meeting to provide the required leverage for grant sources. The Town's increased allocation brings the total local commitment to \$1.5 million. This funding is part of a \$6 million commitment by the Town to housing-related projects and programs that includes:

- \$1.5 million to Mammoth Lakes Housing low-income Access Apartments 11 units
- \$3 million to construct 6 rental units targeted at moderate income households
- \$1.5 million to purchase 6 deed restrictions on new units for moderate income households

"The Town is pleased to be a partner in assisting this project to proceed as it will provide much needed affordable housing for our community." Bill Sauser, Mayor.

MLH purchased the property located at 238 Sierra Manor Road in 2017 through a partial land donation with the intent to convert the two commercial properties into eleven one-bedroom apartments. Since then, the nonprofit has held community workshops, hired an architecture firm, and applied for grants and building permits. The project is considered shovel ready pending outstanding financing.

A local commitment of \$1.5 million in Town funding will allow MLH to leverage approximately \$5,200,000 in State and Federal funds designated for affordable housing development. This investment in community housing will support the community by alleviating overcrowding and providing affordable rents while also assisting local businesses attract and retain employees.


"This significant contribution enables us to leverage the local funds three times over with State, Federal, and additional local grants from partners in the region to create this housing project. It's evident that we need to work together," Patricia Robertson, Executive Director.

As the local nonprofit Community Housing Development Organization serving the Eastern Sierra, MLH hopes to replicate this small, infill affordable housing development model throughout the region to continue to address the housing needs of our communities one project at a time. Occupancy is scheduled in the summer of 2023.

Multi-use Path (MUP) and Road Improvements

- On July 21st, Town Council awarded the \$2.38 million Local Road and MUP Rehabilitation STIP Project to Qualcon Contractors, Inc. This project is anticipated to begin in late-summer/early-fall. Staff has coordinated local utility companies to conduct any necessary infrastructure improvements in the right-of-way prior to paving and staff intends to use any open trench as an opportunity to place conduit for future broadband connectivity.
- The project scope of work includes maintenance of the following streets and MUP's:
 - Mountain Boulevard from Main Street to Sierra Boulevard.
 - Monterey Pine Road from the west end to the turn near 479 Monterey Pine Road, including Monterey Circle.
 - Majestic Pines Road from Meridian Boulevard to Silver Tip Lane.
 - Red Fir Road and Commerce Circle
 - Multi-use Paths (MUP's) see map below:
 - South Highway 203 MUP from Thompsons Way to Trails End Park
 - North Meridian Blvd. MUP from Trails End Park to Sierra Park Road
 - Sections of the Mammoth Creek MUP

MAMMOTH LAKES POLICE DEPARTMENT NEWS...

Police Activity and Services

Forest Service Patrols: The Mammoth Lakes Police Department signs, each year, a Cooperative Law Enforcement Agreement with the USDA Forest Service Inyo National Forest, contracting MLPD to patrol areas within the Forest Service's jurisdiction. These

vehicle patrols are conducted in Shady Rest, the Mammoth Lakes Basin and Minaret Vista from May 24 to September 30 and the U.S. Forest Service reimburses the department for these services. You may notice Police Officers driving through, responding to calls, issuing tickets, or moving along bears in these areas when they are technically outside of the Town Limits. This Agreement with the Forest Service is a great partnership allowing our Agency to engage with Mammoth's many visitors camping in the busier developed campgrounds.

Speeding Enforcement: During the months of June and July, MLPD issued 25 speeding violations on SR 203/Main Street. Many additional drivers were pulled over and received a speed warning. Just having a Police Officer parked on SR 203 likely helped slow speeders down. MLPD's speed enforcement campaigns will continue to help protect our community members, visitors, and wildlife. The department's new mobile radar trailer is still being moved around Town with recent locations including Westbound Main Street at the California Welcome Center, Eastbound 3800 block of Main Street, Minaret Rd. outside of Snowcreek Condominiums, Old Mammoth Rd. at Sherwin Creek Road and on Meridian Rd. to help traffic flow with the graduation parade. The message board on the radar trailer is fully customizable and the current message reads "35 means 35" when you are over the speed limit!

OHV Patrols: MLPD's new OHV Program is very successful so far with 406 miles of trails patrolled, 74 OHV riders and dispersed camper contacted, and 5 warnings issued. The Officers also assisted with an OHV collision on Sherwin Creek Road and helped patrol Crowley Lake during the 4th of July Fireworks. OHV Razor patrols typically include moving along campers from illegal dispersed camping areas, advising on illegal campfires, contacting riders for community engagement, issuing warnings or citations for speeding, expired registration & missing helmets along with assistance in collisions or other emergencies. The goal of the MLPD's OHV program is to provide safety and education for both residents and visitors and to reduce intrusions into the wilderness and other protected areas.

Mammoth Lakes Community Emergency Response Team (CERT): CERT has begun recruitment for new members and a free CERT Academy will take place in October. Police Community Alerts

Mammoth Lakes Basin Parking: A reminder that all drivers in the Lakes Basin must park in either a designated parking space or have their vehicle's tires off the pavement. This doesn't mean off-roading your car into the neighboring forest! However, you can park parallel to Lake Mary Road if all vehicle tires are on the dirt. Parking is very limited this summer and taking the Town's free Trolley to the lakes might be more convenient. Some trolleys tow a courtesy bike rack trailer and muzzled dogs are always welcome. Our Community Service and Code Compliance Officers are patrolling the Lakes Basin daily and parking citations are issued as necessary.

No Overnight Parking at Park & Ride Lot, Corner of Old Mammoth and Tavern Roads: This year, MLPD is asking that all overnight and long-term backpackers park their vehicles in Lots A or B just below Mammoth Mountain's Main Lodge (no reservations needed). Alternatively, vehicles can be parked at the departure trailhead such as the Duck Pass lot at the end of Coldwater Creek. Unfortunately, vehicles will no longer be able to stay overnight at the Town's Park & Ride Lot at Tavern and Old Mammoth Rd. The reason for this parking change is due to the anticipation of record visitation this summer. The small Park & Ride lot, which is already frequently at capacity, is now to be used for day trips, carpooling, and electric vehicle charging. The Police Department reminds all visitors and residents to please keep safety in mind while enjoying beautiful Mammoth Lakes during the summer and fall with the following safety tips:

Driver Safety

- Be aware of the pedestrian crosswalks on Main Street & Old Mammoth Road
- Be courteous to bicyclists and give ample room when passing
- The sun is powerful at higher elevation, never leave children or pets in unattended vehicles, even if the outside temperature feels reasonable

Bicycle Rider Safety

- Obey the rules of the road stop at red lights and stop signs, use hand signals, etc
- Wear a helmet and bright-colored or reflective clothing while riding
- Ride with traffic, never against it
- Bicycle lighting is required at night
- Bicyclists must use the bicycle lane when on a roadway equipped with such lane and the bicyclist is moving slower than the normal speed of traffic

Pedestrian Safety

- It's dark at night in Mammoth Lakes Do not assume drivers can see you
- Pedestrians do not automatically have the right of way

Altitude Safety

- Drink plenty of water
- Moderate activity on the 1st day at elevation
- Use sunscreen and lip protection
- Always bring along layers, the weather can be unpredictable
- Water is cold year-round at this elevation

Wildlife Safety

- Bears are present Keep your doors locked and do not leave food or other scented items like sunscreen, deodorant, chapstick, etc. in your vehicle
- Secure dumpsters after use and do not leave trash/food unattended outdoors
- Black bears are easily scared off by yelling, loud noises and waiving your arms
- Slow down! Speeding kills wildlife and collisions with wildlife will cause major damage to your vehicle

Hiker Safety

- Let someone know where you are going
- Bring enough food, water (not safe to drink out of the streams), clothing, and reasonable safety equipment for the nature of your hike
- Be aware that cellular phone service may not work, Garmin inReach® or spot device is recommended.

Mobility Hub Study Survey

We are conducting a survey that will help us better understand traveler behavior and interests, therefore identifying strategies that will help reduce driving, increase walking, and manage parking, among other things. The <u>Great Basin Unified Air Pollution Control District</u> is a California regional government agency that works to protect the people and the environment of Alpine, Mono and Inyo Counties from the harmful effects of air pollution.

When air quality has reached unhealthy levels, both the GBUAPCD and Mono County Health Department will issue <u>Health Advisories</u>. Inyo National Forest and Bureau of Land Management Fire Restrictions

The Inyo National Forest and Bureau of Land Management Bishop Field Office implemented (Stage 1) fire restrictions on all Federal lands under their jurisdiction. This decision is based on very high fire danger, drought conditions coupled with extremely dry vegetation, an increase in human caused wildfires and the availability of firefighters for response. Seasonal fire restrictions for the Eastern Sierra Region are being implemented in close coordination with the Cal Fire San Bernardino/Inyo/Mono Unit and the Mono County Sheriff's Office. Residential Recreational Fire Restrictions in Mammoth Lakes

In conjunction with the fire restrictions put in place by the Inyo National Forest and Bureau of Land Management which prohibit campfires outside of developed campgrounds and recreation sites, MLFD is prohibiting residential recreational fires within the Town of Mammoth Lakes. If you obtained a permit for a recreational fire pit on your property, it is suspended until further notice. Propane fire pits that do not burn wood will continue to be allowed.

Camp like a Pro!

Learn how you can camp like a pro this summer. The Eastern Sierra Dispersed Camping Collaboration's (ESDCC) developed a five-point campaign to improve management of dispersed camping. Keep Bears & All Wildlife Wild

As the summer season gets underway, the Inyo National Forest and California Department of Fish and Wildlife would like to remind visitors to be vigilant with proper food and trash storage. Working together with visitors, permit holders and private and public entities we can help keep wildlife wild.

We offer the following recommendations for proper food storage and appreciate your participation to this matter. The following recommendations include rules and responsibility with the intent that such practices become the norm and lead to positive experiences when visiting the Inyo National Forest.

Do not leave food or fragrant items without properly storing them. Bears and wildlife have a keen sense of smell and will access your campsite, car, or cabin if you don't take the precaution of storing your food properly. Bear-resistant containers, including equine panniers, are the most effective method of food storage. Use bear resistant food lockers (normally 48 inches wide, 29 inches deep and 38 inches high (24 cubic feet). Lockers are at many trailheads and campgrounds to be shared by visitors. Space in lockers is limited so bring only what you will need during your trip. Deposit trash in bear resistant trash cans, not in lockers.

Non-food items such as plastic bottles, water bottles, coffee mugs, pet food, empty cans, trash, wrappers, cosmetics, grocery bags, boxes, and ice chests must also be secured. Do not leave these items in your car or tent. Removing such items may help deter a bear from entering and doing damage to property. Always clean up your camp of food and trash promptly after meals so that bears are less likely to visit your camp. If you have a child who

uses a car seat, please consider cleaning the car seat, because too often there are food particles found in car seats that may attract bears. Other attractants such as bird feeders & bird houses (not authorized) could also attract a bear, and should not be placed on forest system lands. Please discontinue this practice.

In all wilderness areas of Inyo National Forest, use of bear-resistant containers is strongly recommended. There are eight specific areas where using a container that prevents access by bears is mandatory: Bishop Pass Area, Cottonwood Lakes Basin/ Cottonwood Pass Area, Duck Pass/Purple Lake Area, Fish Creek Area, Kearsarge Pass Area, Little Lakes Valley Area, Mammoth Lakes/Rush Creek Area, and the Mount Whitney Area. Bear containers are preferred over counter-balance hanging because trees are limited above certain elevations, and where they do occur, they are easily accessible to climbing bears. Bear proof designs are proven deterrents, odor proof, weigh less than 3 pounds, and come in hard and soft designs.

Black bears (Ursus americanus) are the most abundant and widely distributed bear; they have been recorded in all states except Hawaii. Black bears can vary in color from jet black to cinnamon to white. Bears eat a variety of plants and animals; their diets consist mainly of grasses, roots, berries, insects, and fish and animals, including dead animals. They have an acute sense of smell; they can smell a scent from miles away. Although black bears rarely kill or seriously injure people, when they do, it's most often the result of predatory behavior by single males. Most conflicts between humans and black bears occur when bears access and become addicted to human food sources.

When To Make A Bear Call

DO NOT CALL:

- Bear walking through your property or neighborhood
- Bear in a tree

OPTIONAL NON-EMERGENCY

- Bear on porch or deck
- Bear in unoccupied vehicle
- Bear making regular visits to property or under deck or house
- Bear sitting in a hammock (call us so we can come and take a photo!)

EMERGENCY - CALL 911:

- Bear inside any building or home
- Bear seen trying to open window or door of occupied dwelling
- Bear in confined space with human beings
- Bear apparently confronting human beings

Register for CodeRED

Residents of Mono County can register their cell phones to receive emergency CodeRED (reverse 911) alerts from Mono County. This is a county public service

available to all Mono County residents so please tell your friends and neighbors in Mono County that they can register for this service. CodeRED announcements are for personal notification and will not replace CERT CAHAN notification. Here is how to sign register/sign up using the INTERNET:
