SUBJECT: Notice of Intent to Adopt/Notice of Availability for the Sign Code Update Initial Study/Mitigated Negative Declaration

This serves as the Town of Mammoth Lakes (Town) Notice of Intent to adopt an Initial Study/ Mitigated Negative Declaration for the Sign Code Update, prepared in accordance with the California Environmental Quality Act (CEQA), State CEQA Guidelines and local implementation procedures.

PROJECT TITLE: Sign Code Update ("Project")

**PROJECT LOCATION:** The Project would apply to all land within the Town of Mammoth Lakes Urban Growth Boundary (UGB) in Mono County, California.

**PROJECT DESCRIPTION:** The Project is a comprehensive update of the Town's Sign Code, Chapter 17.40 of the Municipal Code. The Sign Code regulates all signs within the Town's UGB. The Project incorporates some sign regulations already in place in The Village at Mammoth. The Project would allow new sign types such as halo lit signs, signs with neon details, electronic message signs, and sales/promotional banners subject to limitations. Additional provisions would be included to provide more flexibility in signage types and designs and encourage pedestrian oriented signs.

NOTICE IS HEREBY GIVEN THAT the Town of Mammoth Lakes proposes to adopt a Mitigated Negative Declaration for the above-cited Project. The Mitigated Negative Declaration is based on the finding that, by implementing the identified mitigation measures, the Project's potential significant adverse impacts will be reduced to a less than significant level. The reasons to support such a finding are documented by an Initial Study prepared by the Town of Mammoth Lakes.
